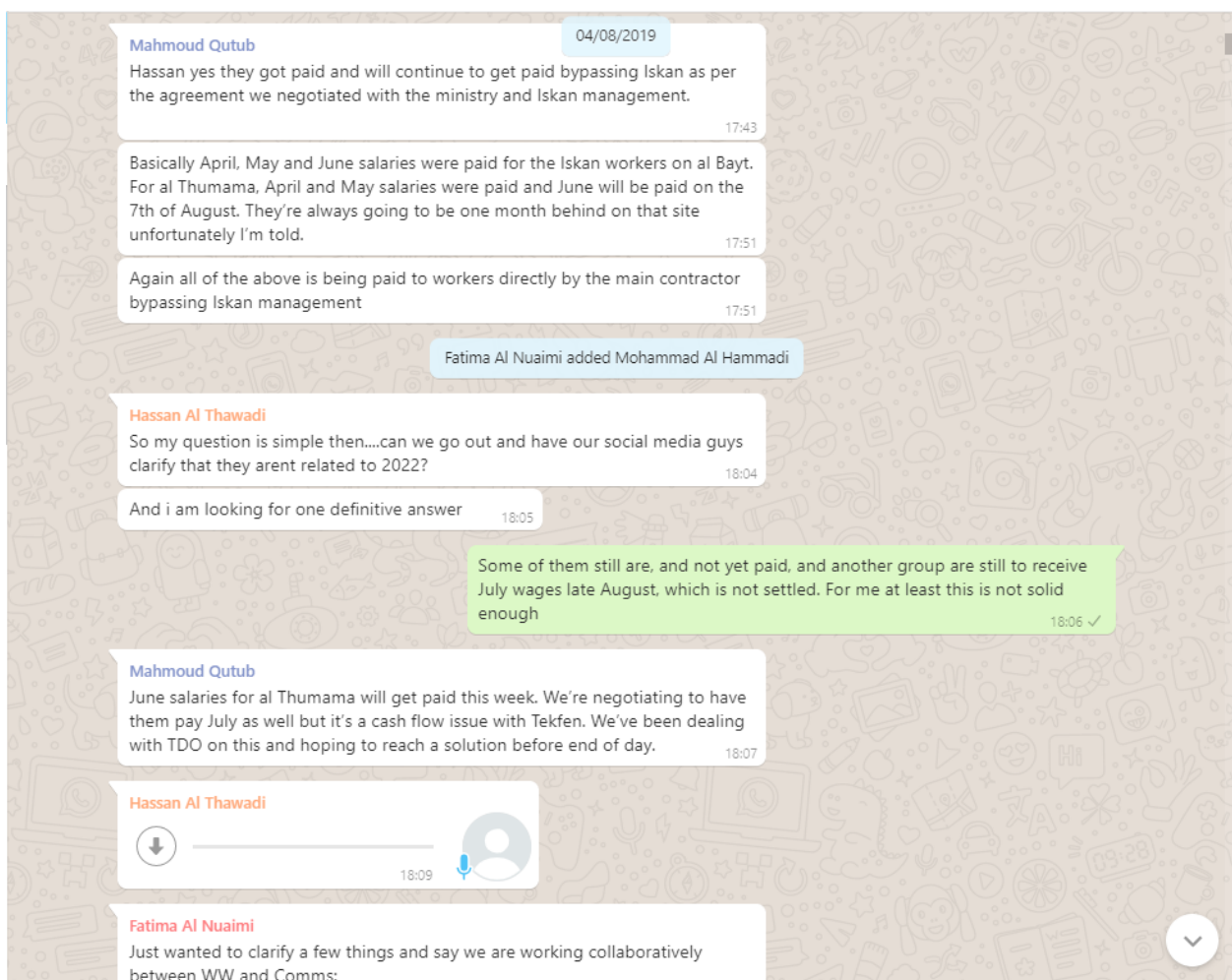
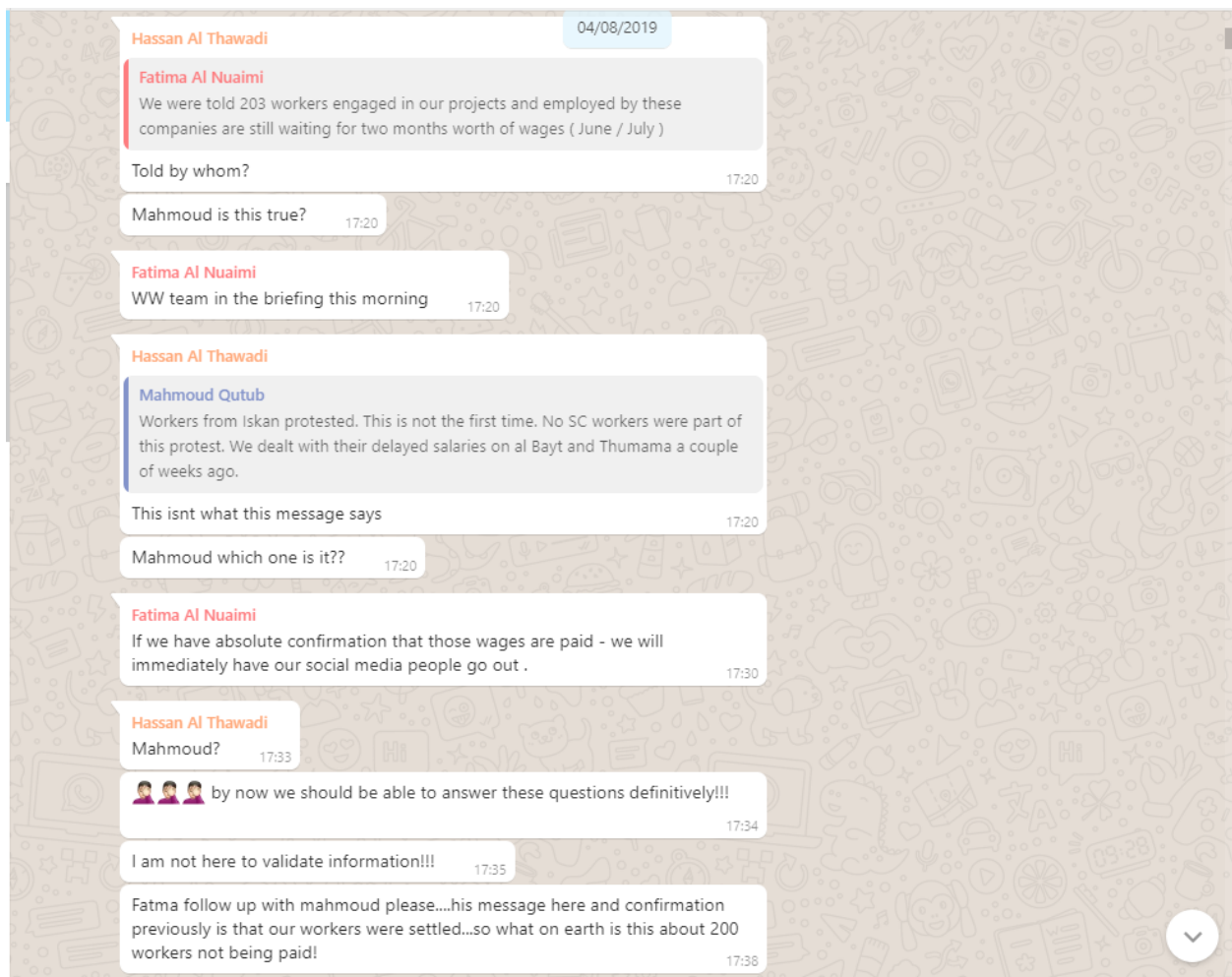

Just wanted to clarify a few things and say we are working collaboratively between WW and Comms:

Regarding today's issue, we have just had confirmation from WW Comms that our workers were not part of today's demonstration.

Therefore can confirm that:

"SC workers engaged on 2022 World Cup projects were not part of today's protests regarding delayed payment of wages."

We would advise taking this position that they were not out protesting due to delayed wages as we can't resolutely say they have been paid as some still have not;

If our audit system identified this issue, then we can go publicly showing the effectiveness of our audit. But if the issue is brought by worker or external then it may impact negatively on us.

We need these facts confirmed before acting.

WW Comms and SC Comms have been communicating on this issue since 10.00am this morning when we were made aware of the issue;

Both teams sat at 11.30am and discussed scenarios - we said we'd need wait for 100% confirmation on the facts and to assess the spread of the story on social media before confirming next steps;

Important point: Moving forward we will be sure to state both teams are aligned/aligning on any issue and to say we will revert to this group with next steps rather than leaving it open to debate like it has today.

Please note we will share a summary of any additional pick up there has been shortly.

Hello All, this is Mohammad Al Hammadi, me and Abdullah ibhais have just been to the strike site and spoken to workers there, the overall settlement they were promised is 2 months salary.

For now they are saying they have no food on daily basis, they do not have their ids, they are not given any leave and those who ask for leave are kept for 4 months without payment before getting cancelled.

They say that when they did a strike inside 4 weeks ago police came and forced them to go to work without payment.

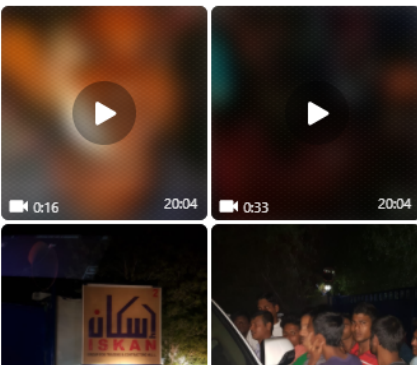
In addition to the ones discussed above we have met workers from QF site they said they have not been paid for four months and that iskan was sacked from site but no one has paid them, they are a total of 125 who worked at Qatar stadium. We met 12 of them but only two agreed to go on camera. We also met workers from Al Bayt and so far the only communication with them was from the police promising two months payment, but they said they have not received salaries for four months now.

We also shared our mobile numbers with to get the names of the workers who have not been paid for four months as they claim, in order to confirm Iskan's update.

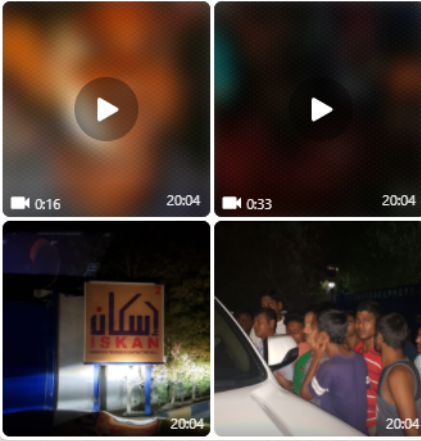

They committed to doing it. June salaries will be paid tomorrow and we're optimistic that July will also be paid. This means that by the end of the week we would have been caught up with paying the salaries of all Iskan workers on our sites. This should help with the positive narrative.

I believe regardless of whether or not SC workers participated, the matter of the fact remains that we have workers that have not received June and July salaries. Any spin we try to put on the delay will risk the State reputation because it would be an admission from us that there is indeed an issue with payments - in fact so bad that we have to pay the workers directly and in cash - because the wage protection system and electronic records failed them.

It makes us look really bad that all these reforms we've been talking about "accelerating as a result of the World Cup" still cannot fix issues. Only response I see making things better is saying it's been resolved. Nothing else we say will do anything except cause more damage
